

NOTICE TO BIDDERS

CITY OF FOSTORIA, OHIO

Sealed bids for **LARGE DIAMETER SEWER HEAVY CLEANING AND TELEVISIONING**, will be received in the office of the Safety-Service Director by the City of Fostoria, Ohio, at the Municipal Building, 213 South Main Street, Fostoria, Ohio 44830, until 4:00 p.m. (local time) on **JULY 22, 2010** at which time and place they will be publicly opened and read aloud.

The Engineer's opinion of probable construction cost is \$250,000.

Copies of the detailed plans, specifications and contract documents may be obtained or examined at the office of the Fostoria City Engineer, Municipal Building, 213 South Main Street, Fostoria, Ohio 44830 between 9:00 a.m. and 4:00 p.m. on Monday thru Friday. Questions shall be directed to the City Engineer's Office at (419) 435-9775 or (419) 435-4192 fax or emailed to cityengineer@ci.fostoria.oh.us.

A payment of fifteen dollars (\$15.00) will be required for each set of detailed plans, specifications and contract documents. Checks shall be made payable to "City of Fostoria, Ohio" and all documents become the property of the prospective Bidder, with no portion of said payment being refunded. No set shall be mailed less than three (3) days before the date on which bids are due.

Should a bidder find any discrepancies in or omissions from any of the documents, or be in doubt as to their meaning, he shall advise the Engineer in writing, who will issue necessary addenda, or revised drawings, as may be appropriate. However, no request for clarification/information will be accepted after three (3) days before the date on which bids are due.

Successful Bidder must be an Equal Employment Opportunity Employer, which prohibits discrimination based on race, creed, color, national origin, sex, age, handicap, political affiliation, or beliefs. The City of Fostoria is an Equal Employment Opportunity Employer.

Proposals must be submitted on the form furnished by the City and must contain the name of every person, firm or corporation interested therein. Bids shall be sealed and marked as "**LARGE DIAMETER SEWER HEAVY CLEANING AND TELEVISIONING**" and mailed or delivered to the City of Fostoria.

Bidders are required to file with their bid a Guaranty Bond in the **full amount** of the bid or a certified check, a cashier's check or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in the amount of 10% of the bid.

The proposal bond or certified check submitted with the bid will be held as a guarantee that if the proposal is accepted, a contract will be entered into. Proposal bonds and certified checks will be returned to all Bidders after the contract has been entered into and secured by a performance bond of 100% of the contract with a satisfactory surety for the faithful performance of the work.

The successful bidder will be required to execute an affidavit relative to delinquent personal property taxes pursuant to the provisions of Section 5719.042 of the Ohio Revised Code prior to entering into a contract with the City.

No Bidder may withdraw his bid within 60 days after the actual date of the bid opening.

The City of Fostoria, Ohio intends to accept the lowest and best bidder for the project but reserves the right to reject any and all, or parts of any or all bids and to waive any minor informalities in any bid, or to make the award in the best interest of the City.

A pre-bid conference will be held on July 8, 2010 at 10:00 am in the Municipal Building 2nd floor conference room for interested contractors.
