

**Request for Bids**

Sealed bids will be received until 4:00 p.m. (local time), Thursday, July 22, 2010, and then publicly opened and read in the Office of the Safety-Service Director of the City of Fostoria, Ohio at the Municipal Building, 213 South Main Street, Fostoria, Ohio, 44830, for furnishing all labor, materials and equipment, and performing all work necessary to **REHABILITATE WEST APRON INCLUDING GRADING, DRAINAGE, ASPHALT PAVING, LIGHTING, MARKING, FENCING, AND TURFING** at the Fostoria Metropolitan Airport.

The Engineer's opinion of probable construction cost for the project is \$84,000.

Bidders are required to file with their bid a Guaranty Bond in the full amount of the bid or a certified check, a cashier's check or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in the amount of 10% of the bid.

Bids may be held by the City for a period not to exceed 90 days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The City of Fostoria, Ohio intends to accept the lowest responsible bid for the project but reserves the right to reject any and all, or parts of any or all bids and to waive any minor informalities or irregularities in any bid, or to make the award in the best interest of the City.

Should a bidder find any discrepancies in or omissions from any of the documents, or be in doubt as to their meaning, he shall advise the Engineer in writing, who will issue necessary addenda, or revised drawings, as may be appropriate. However, no request for clarification/information will be accepted after three (3) days before the date on which bids are due.

Proposals must be submitted on the forms furnished by and in the documents and must contain the name of every person, firm, or corporation interested therein. Bids shall be sealed and marked as "**REHABILITATE WEST APRON**" and mailed or delivered to the City of Fostoria, 213 South Main Street, Fostoria, Ohio 44830.

This project is subject to the requirements of the Davis-Bacon Act as amended. The Contractor is required to comply with wage and labor provisions and to pay minimum wages in accordance with the schedule of wage rates established by the US Department of Labor.

Award of contract is also subject to the following Federal provisions:
